## 1.0 FOREWORD BY BOARD CHAIRPERSON



Dear members and partners, I greet you with utmost gratitude. I wish to yet again share with you the LASPNET Annual Report for the year 2021/2022. It's exactly two (2) years ever since we took the fort to steer the Network. On my own behalf as well as the other Board members, I am extremely humbled by the trust you accorded us from the onset, throughout our tenure in office until this day as the Network warms up to elect a new breed of leadership.

Our experience while serving on the LASPNET Board has been worthwhile. We take pride to have witnessed a steady growth in the Network's funding portfolio with the coming on board of new development partners who include European Union; East West Management Institute (EWMI); Freedom House; GIZ, CORDAID and HiiL. Whereas majority of these donors support short term projects, they have significantly enabled LASPNET to reduce on the burden of over depending on a single donor that is DGF whose funding came to an end effective 30th September 2022 in accordance with the signed partnership agreement.

The visibility of LASPNET remains unrivalled in many spaces due to its long term investment in creating strong partnerships with both state and non-state actors. The media for instance has continuously build trust in LASPNET as a reference point on access to justice, rule of law and human rights issues. The Judiciary also exhibited a vote of confidence in LASPNET by nominating our CEO (Dr. Sylvia Namubiru Mukasa) on the Judiciary Taskforce that developed the Judiciary Anti-Corruption Strategy (Yet to be approved). We are immensely grateful for such strategic partnerships and confidence.

As a family, in this one year we have had two members of the Board ascend to the bench. Her Worship Bridget Nasasira, the Western Region Representative and His Worship Tonny Ojok Obonyo the Northern Region Representatives are now both Grade One Magistrates. For LASPNET, we have strategic partners and ambassadors of access to justice, legal aid and rule of law.

The work of LASPNET's lobby and advocacy arm is one which cannot be overemphasized. For instance, our protracted advocacy journey for the National Legal Aid law has started bearing fruits. That is to say, in February 2022, the Private Mover (Hon. Silas Aogon) was granted leave of Parliament to introduce the Private National Legal Aid law. Subsequently, in March 2022, the Private Mover received a certificate of financial implication from the Ministry of Finance underscoring the fact that the National Legal Aid law would help to enhance equity, fairness and socio-economic development. The latest update is that the Private Mover was able to present the bill on the floor of Parliament for the first reading on 27th September 2022. We are optimistic that more than before the National Legal Aid Bill 2022 will soon be enacted into law.

On the angle of institutional sustainability, the Board is glad to report that working closely with Management, we have been able to develop a Sustainability Plan 2021/2025 and part of our undertaking was to secure land for the Network. As we leave office, we handover to the incoming board a piece of land in Nakawuka Jjungo and urge them together with Management to take forward the task of mobilizing resources to construct the Legal Aid House. Like it is the case in life, as we pursue success, challenges are a given.

LASPNET continued to experience several challenges at the macro level that hampered its work. The continued closure of DGF affected the operations of both the Secretariat and its members. This was further exacerbated by the news of DGF closure after government suspended its operations in Uganda.

In relation to the above and to overcome the continued shrinking civic space and its impact on LASPs operations, LASPNET was a proud recipient of the Resilience plus fund which is aimed at building organizational resilience and sustainability of the Secretariat and some of its selected members including Human Riahts Focus (HURIFO): Platform for Labour Action (PLA) and Foundation for Human Rights Initiative (FHRI). It's hoped that the Secretariat will cascade the best practices learnt from this project to benefit other members in terms of strengthening their capacity to respond to the fragile operating environment.

As the outgoing Board of Directors pave way for the new ones, I wish to

reiterate that despite the challenges, LASPNET remains a firm and strong Network thriving from growth to growth. On that note, we are confident that with the good will and support of the Board, Membership, Management and Staff, LASPNET's brand will be jealously guarded. We further remain available to offer guidance and support whenever service calls.

As I conclude, I wish to commend our Development partners both past and present for the unwavering financial and technical support. It's your trust and confidence that has kept the Network alive and functional. The Membership is also appreciated for choosing to be a part of LASPNET. Hasten to add, the Network is as strong as its members, that's why our members are highly valued.

To the outgoing Board, there is no great team I would have ever chosen to lead with than yourselves. Our philosophy was working together and achieving together. I thank you! The Management and Secretariat staff led by the able CEO, we hold you highly for having simplified our work. Your cooperation was top notch and no amount of words can express our gratitude to you.

## **2.0 THE ANNUAL STATEMENT** FROM THE OFFICE OF THE CHIEF EXECUTIVE

o all our esteemed Members, Stakeholders and Development partners, I am profoundly honored to present to you the LASPNET Annual report for the period July 2021 - June 2022.

During the period under review, guided by its new Strategic Plan (2021/2025), LASPNET remained steadfast in fulfilment of our mandate of enhancing the promotion of Rule of Law and Access to Justice for rights holders in Uganda. The progress made by LASPNET and GNPF on advocacy for the National Legal Aid Law stood out among the so many successes we achieved this year. I therefore take this singular opportunity to appreciate all actors within and outside the Network that worked towards fast tracking the enactment of the National Legal Aid law. We are also glad that our development partners are in sync with the ongoing efforts to fast track the enactment of the National Legal Aid law.

To re-echo the words of my Board Chairperson, the enactment of this law ought to have been done yesterday, therefore let's continue to support the Private Mover and Seconders as they progress with the next steps for having the NLAB passed into law.

Our long term expertise as a research hub on Access to Justice, Human Rights and Rule of law managed to gravitate us into several spaces. For instance, LASPNET was invited to make presentations by the Judiciary; Uganda Human Rights Commission and Uganda Women's Parliamentary Association.

Its noteworthy sharing that



working with United Nations Office of the High Commissioner on Human Rights (UNOHCHR) and ASF we prepared a paper to the Judiciary providing our comments and views on the proposed State Brief, Bail and Sentencing guidelines and several of our recommendations were captured in the new set of guidelines launched by the Judiciary on 28th July 2022.

On the part of Networking, Coordination and Partnerships, we have been able to maintain our membership at 53 LASPs spread across 80 districts in Uganda. At the recent AGM, two new members that is Center for Health. Human Rights and Development (CEHURD) and Urban Refugees Rights Programme (URRP) were admitted into the Network each coming on board with a unique mandate hence creating diversity within the membership and we are looking forward to admitting new members as individuals and organizations. LASPNET was also the convener of the Access to Justice Cluster under the Universal Peer Review (UPR) processes led by the National Coalition for Human Rights Defenders (NCHRDs). We significantly utilized the UPR space to develop the Access to Justice Report highlighting several gaps and recommendations for enhancing access to justice in Uganda. Some of the policy recommendations raised in the report included the need to challenge the continued practice of trying civilians in the court martial as well as the need to fast track the enactment of the National Legal Aid Law which recommendations were adopted at the UPR. Still under Networks, we continued to maintain our existing development partners in addition to bring on board new ones such as GIZ and HiiL.

More interesting to note, we were also able to discharge our mandate of strengthening the capacity of our members through a myriad of trainings on GBV under the EU project and navigating the CSO enabling environment by Paralegals under the Civil Society Strengthening Activity (CSSA) supported by EWMI and ICNL.

Quite significant for the year under review though joint effort of Management and aware of the need to adapt organizational sustainability we were able to secure a piece of land in Nakawuka, Jjungo in Wakiso district measuring one (1) acre where we intend to establish the Legal Aid House. We anticipate to have several facilities includina conference and training facilities at the proposed Legal Aid House. High on the agenda in next few years will be to mobilize resources to identify development partners to support us actualize our dream for the Legal Aid House.

Not to say that the reporting period was smooth throughout, we also experienced bumpy slopes as evidenced by the continued shrinking civic space. That is to say, the continued suspension of DGF and later its exit from Uganda hugely impacted on the operations of Secretariat. DGF was our institutional donor funding about 75% of the staffing as well as programme implementation. As such we have had to lay off staff till we get alternative funding. In same vein many LASPs and Strategic partners formerly funded by DGF will equally fill the pinch not to mention the beneficiaries, service providers and the wider economy which fed-off DGF.

Furthermore, on side of human rights violations, we witnessed attacks on the HRDs and Activists. For instance, the gruesome torture of Novelist and Satirical Writer Kakwenza Rukirabashaija remain fresh in our memories!

The challenges notwithstanding, we have remained focused, resilient and enthusiastic to the future of Legal Aid and Access to Justice. To this end, allow me extend our sincere gratitude and appreciation to our development partners including DGF, IDLO, UNDP, Freedom House, OXFAM, EWMI, ICNL, ADA, GIZ and CORDAID that supported our work as you will read from this Annual Report.

Finally, on my own behalf and that of Management and staff, I take the privilege to appreciate our outgoing Board of Directors for the job well done. We shall forever be grateful for their commitment, professionalism and oversight support that we benefited from as we went about our work. We are optimistic that the incoming Board will take forward the current and future intentions of the Network. For the Membership, we are extremely proud of you all. Last but not least, I thank my team at the Secretariat for the support and fidelity to your work amidst the challenges.

## 5.0 A COMPARATIVE ANALYSIS INTO THE OPERATING ENVIRONMENT OF LASPNET FOR THE YEAR 2021-2022

n this year's (2021/2022) Annual Report, the Secretariat has attempted to undertake a comparative analysis of the operating environment and its impact on LASPNET programming in the last three years (2018/2019, 2019/2020 and 2020/2021). The analysis is based on three (3) indicators namely; Membership composition, Manifestation of CSO threats and Challenging affecting LASPs.

#### a) Membership composition

LASPNET membership in the last three years has remained consistent. In year 2018/2019 the Membership stood at 52 LASPs. There was an increment of one (1) member that is New Plan in the 2019 making the number of LASPs to 53. In year 2020, there was increment in the number of LASPs from 53 to 55 following the admission of two member organizations that is Legal Hub and Women with a Mission. However, the number reduced to 54 in 2021 following the admission of two organizations that is URRP and CEHURD and also deregistration of three members that is ASF which upgraded to level of strategic partner whereas the other 2 deregistered members included Uganda Youth Development Link (UYDEL) and Law and Advocacy for Women in Uganda (LAWU).

**To note:** Whereas the number of LASPs would have increased beyond the current numbers, LASPNET values a quality and relevancy of its membership and often

deregisters members who have constantly failed to meet their obligations. Therefore, the reduction in numbers shouldn't be interpreted as loss of confidence but rather strength in the purpose and core mandate and intentions of the Network. It rather not be about the numbers but instead relevancy and value addition a member brings to this forum.

### b) Manifestation of CSO threats

From the last three years (2018-2021), it's clear that the threats to CSOs operations including LASPNET have metamorphosed from Office Break-ins to legal restrictions including FIA and NGO Act and later suspension of donor's work the latest affected being DGF which is anticipated to exit from Uganda by the end of 2022. LASPNET therefore recommends that beyond strengthening physical security, there is need for CSOs to strengthen their legal compliance to reduce on the regulatory overreach often associated with closures as well as invest in organizational resilience and sustainability. This would also necessitate institutions to diversify their income streams as a strategy for minimizing the risk of overdependence on one donor.

### c) Challenges affecting LASPs Sustainability

The challenges documented overtime affecting LASPs functionality and sustainability include loss of funding due to lack of accountability and weak governance structures especially in the year 2018-2019. The outstanding challenge for 2019-2020 was COVID 19 and the subsequent lockdown which affected the operations of LASPs. During that time, legal aid services were classified as non-essential and as such lawyers denied access to travel to prisons and police to respond to emerging human rights violations including arbitrary arrests and unlawful detention. Equally, the year 2020-2021 was an election year, punctuated with human rights violations such as torture and enforced disappearances of citizens. Furthermore, it was during the same time that LASPNET was denied accreditation by the Electoral Commission to observe and monitor the 2021 general elections. To address

such constraint LASPNET redesigned its interventions on elections to focus on its core mandate of research and knowledge management as well as advocacy through deployment of Rapid response lawyers and paralegals to respond to human rights violations arising out of the pre, during and post-election period and generation of information related to access to justice, rule of law and human rights arising during the election period.

## 6.0 HIGHLIGHTS OF KEY ACHIEVEMENTS

The operating environment analyzed above notwithstanding, LASPNET has continued to leverage and consolidate its niche of promoting Legal aid as a vehicle for enhancing access to justice for the poor and vulnerable persons. This has been achieved through the Network's strategic thematic areas which include; Networking, Coordination and Partnerships, Lobby and Advocacy, Research and Knowledge Management and strengthening Institutional Capacity of its members. Under this segment we present the key highlights under each theme in summary.

### 6.1 Networking, Coordination and Partnerships

In the year 2021/2022 LASPNET sustained its collaborative platforms in several ways which among others included:

- Maintaining the existing partnerships with the different state and non-state actors who include: JLOS institutions; NSSF, UCBA, ASF, Development Partners among others.
- Convening of the 6th Annual PRE-AGM E-learning session under the theme: "Growing and Sustaining a Resilient Legal Aid Sector in Uganda" on the 21st October 2021.
- Launch of the Investigative Documentary titled "Defiled by my Father" on the 23rd October 2021 at Golden Tulip Hotel.
- Convening of two (2) regional engagement meetings between

Formal and Informal Justice actors on the 5th -6th August 2021.

- Convening of the National conference on MHPSS for SGBV Survivors under the theme; "Strengthening Mental Health Psychosocial Services for SGBV Survivors in Uganda; Reflecting on the Milestones Challenges and Opportunities" on the 29th October 2021 in partnership with CORDAID and TPO held at Hotel Africana.
- Conducting of 7th CEO Annual Forum under the theme "The role of Legal Aid Service Providers (LASPS) in enhancing Sustainable Legal aid service provision in Uganda," on 11th April 2021 at Hotel Africana.

### 6.2 Research and Knowledge Management

In the reporting period, LASPNET undertook key research to strengthen evidence-based advocacy as well as provide relevant information for use by its members which included among others;

- Paralegal Voice Magazine (2nd Edition).
- Annual Access to Justice Trends Analysis, 2020.
- Training Handbook for CSOs and Paralegals on promoting an Enabling environment.
- GBV Training Manual and GBV Handbook for informal justice system actors.

# Six papers on topical issues of Access to Justice and Rule of law which were prepared include;

- A paper titled "Perceptions on the Administration of Justice in Uganda" was presented at the 23rd Annual Judges Conference held on 31st to 2nd February at Mestil Hotel.
- A paper on the implication of the Speaker's ruling on the Business of the 10th Parliament delivered during the online meeting convened by CEPIL on the 6th October 2022.
- A paper on the analysis of implementation of the CEDAW and Maputo Protocol in Uganda delivered at the UWOPA meeting
- A position paper on the proposed Bail, State Brief and Sentencing guidelines was submitted to the Judiciary Rules Committee and Chief Justice on the 2nd March 2022.
- Presentation on LASPNET's Perspective on enforced Disappearances in Uganda and the Human Rights Implications in 2021 at the 24th UHRC consultative meeting held on the 22nd February 2022 at Fairway hotel.

### 6.3 Lobby and Advocacy Engagements

### On Lobby and Advocacy front, LASPNET achieved the following;

 Tabling of the National Legal Aid Bill (2022) in Parliament on 9th February 2022 by the Private Mover, Hon. Silas Aogon.

- Conducted a 2-day residential meeting with the Legal and Parliamentary Affairs Committee to discuss the National Legal Bill on
- Holding of the Development Partners Round Table Meeting held on 18th May 2022 at Serena Hotel.
- Convening of the Orientation and Lobby Breakfast Meeting with Committee and Caucus Chairpersons of the 11th Parliament on 21st June at Fairway Hotel.
- Convening of GBV Annual Awareness Days and use of social influencer like Golola Moses in Buikwe district on 19th May 2022, Kayunga district on 26th May 2022 and Mukono district on 2nd June 2022.
- Media engagements where a total of 78 media appearances and mentions were captured reporting about LASPNET's work and events.
- Commemoration of GBV Awareness Days in Buikwe, Kayunga and Mukono, Masindi and Kasese Legal Aid Open Days and the 7th CEO's Forum.
  - Conducting of Legal Aid Open days in Masindi district on 29th April 2022, Kasese district on 7th June 2022 and Kitgum district on 22nd July 2022.

### 6.4 Institutional Strengthening and development

In the reporting period, LASPNET built the capacity of its members through undertaking several thematic based trainings as mentioned below;

- Training of Informal Justice Actors to effectively prevent and respond to Gender Based Violence (GBV) within the districts of Mukono, Buikwe and Kayunga held on 16th to 19th August 2021 at Colline Hotel Mukono.
- Training of Legal Aid Service Providers on Evidence Based Practice for Effective Service Delivery held on 27th October at Protea Hotel.
- Convening of the 6th Pre-AGM E-Learning Session virtually hosted by the Secretariat on the 21st October 2021.
- Launch of the LASPNET Strategic Plan 2021/2025.

- Training of Paralegals and CSOs on promoting an enabling environment held on the 13th to 15th July 2022 at Esella Country Hotel.
- A total of two (2) new Development partners that is GIZ and HiiL were brought on board.
- Two (2) new members that is Network namely; Urban Refugee Rights Programme (URRP) and Center for Health Human Rights and Development were ushered into the Network by the 12th AGM held on 22nd October 2020 at LASPNET Secretariat.
- Securing of land for the Network measuring one (1) acre in Nakawuka, Jjungo Wakiso district.
- Development of the DGF End of project evaluation report for the period April 2018-May 2021.

## 7.0 THE YEAR 2021-2022 IN DETAIL

### 7.1 NETWORKING AND PARTNERSHIP

Through the Networking and Partnership buildina thematic area. LASPNET has continued to sustain its existing partnerships with both state and nonstate actors, attract partnerships through engagements and meetings to respond to various human rights and rule of law issues in the country and solidification of the private public partnership in enhancing access to justice for the rights holders. This section highlights various networking and partnership activities undertaken during the reporting period.

#### 7.1.1 LASPNET COVENES VIRTUAL ENGAGEMENT MEETINGS WITH FORMAL AND INFORMAL JUSTICE ACTORS FROM NORTHERN & WESTERN REGION

On the 4th and 5th August 2021, LASPNET with support from IDLO convened a twoday virtual regional engagement meeting with informal and formal justice actors for Northern and Western region respectively under the theme **"Exploring synergies between formal and informal justice systems to enhance community justice initiatives."** 

The engagement meetings were purposed on harnessing effective strategies for fostering collaboration between formal and informal justice systems in the delivery of access to justice.

The meetings were attended by 71 participants (48 Male: 23 Female) from the Judiciary; ODPP; Police; Local Government; Cultural and Religious leaders as well as LASPs.

Dr. Sylvia Namubiru Mukasa, the CEO of LASPNET, in her remarks underscored the fact that the community needed to know the laws and where to go to enforce these laws for access to justice to be realized.

Ms. Jennipher Achaloi, the IDLO representative while presenting on the role of Development Partner's support towards strengthening of Community Justice, appreciated LASPNET for the innovative mind of convening the meeting amidst the pandemic as a way of ensuring continuity of Access to Justice initiatives. She noted that the theme of the meeting challenges development partners to show what they have done to enhance Access to Justice with the exception of providing funds.

In her remarks, Her Worship Susan Ayeko, acknowledged and comprehended the challenges people face in their quest for justice. She stressed the need to skill and build capacities of the informal justice actors. She added that the Ugandan legal system is clogged with cases filed more than ten years still pending hearing since the justice system is highly monetized and characterized by a lot of adjournments which slow down the justice chain and yet those matters can be referred to Ker Kwaro or to religious leaders who can provide a fair and speedy remedy in their communities.

Similarly, on the 5th August 2021, the Western engagement took place and it was graced by the Chief Magistrate of Mbarara, His Worship Twakiire Samuel, the Imam of Mbarara - Imam Abdul Fattah Isa, and Board Representative -Western Ms. Bridget Nasasira among others.

H/W Twakiire Samuel, the Chief Magistrate of Mbarara, acknowledged that LASPNET is a key partner in the promotion of Access to Justice in Uganda. He explained that, he previously knew the role of informal justice actors however, he had no clear comprehension of their impact as it had been explained in the meeting. *"I have discovered that informal justice is as old as mankind! LASPNET has tried to answer questions of this nature through its numerous Access to Justice researches"* he added.

In conclusion. dialogues the two resulted into development of a paper presentation titled the "The role of formal and informal justice as dispute resolution mechanisms: lessons from the regional engagement dialogues in Western and Northern Uganda." This paper was presented by the CEO at the National Advocacy Dialogue on Formal and Informal Justice Actors held on 19th August 2022 at Hotel Africa. Some of the recommendations highlighted in the paper included the need to recognize decisions of informal justice systems by formal justice systems; the need to popularize informal justice systems; the need to increase participation of informal justice actors on DCC structures; the need to undertake a comprehensive research on

the existing linkages between formal and informal justice systems as well as the need for development partners to fund informal justice systems to help decongest the formal justice institutions like courts of law.

# 7.1.2 Coordination of partners in implementation of the Lwengo Legal Aid Model

LASPNET In the reporting period. developed a documentary for the Lwengo crowdfunding project featuring partner voices from the Lwengo district Local Government and LASPNET highlighting the successes, challenges and opportunities under the project. This documentary disseminated via membership was Emails and WhatsApp groups purposely create awareness and resource to mobilization tool for the Lwengo crowd funding project. Furthermore, the Lwengo Crowd funding project continues to be implemented by LASPs who are part of this initiative. That is to say, FIDA Uganda in Lwengo district, MCJL in Omoro district and UCLF in Kayunga district. They all have available office spaces provided by the districts leadership

### 7.1.3 The Implementation Execution of Court Orders Project in 21/2022

LASPNET in partnership with the Uganda Court Bailiffs Association (UCBA) with funding from DGF continued to implement the execution of Court Orders Project aimed at supporting the poor and vulnerable complete the justice chain to enable clients realize benefits from litigation.

#### a) Case management

LASPNET retained court bailiffs who have supported execution of successfully litigated cases by LASPs. The project following suspension of DGF mainly focused on continuing cases since there were no new cases received.

Therefore in the reporting period, follow up of the pending 31 cases was undertaken and out of which 2 cases were executed successfully. The above cases were forwarded by LASPs such as Justice Centres, PILAC, CJAF, ULS-LAP and PLA.

It is worth noting that the follow up on pending cases has been constrained by the fact that some of the cases involve vacant possession which takes notice of 90 days hence affecting timely execution of pending cases; some of the cases have stalled in instances where the judgment debtors have died and there is need to change application for execution to include the administrators of the Estate of the deceased judgment Debtors.

Notwithstanding the above, the Secretariat continues to engage Uganda Court Bailiffs Association (UCBA) to ensure that all pending cases under execution are completed amidst the challenges.

#### 7.1.4 LASPNET, NSSF and Wakiso Human Rights Committee Commemorate the International Human Rights Day.

LASPNET in partnership with National Social Security Fund (NSSF) and Wakiso Human Rights Committee coordinated and participated in the Human Rights Awareness week which took place from 6th to 10th December 2021. The activities during the week included provision of on-spot legal advice and counselling, sensitization on human rights and NSSF compliance as a result, over 400 clients benefitted and encouraged to save with the NSSF Scheme.

To crown off the long week activities, was the commemoration International Human Rights Day at Wakisha Resource Centre, Wakiso District under the theme *"International Human Rights Day was held under the theme; Reducing Inequalities and Advancing Human Rights in Wakiso District."* 

The event was officiated by H.E Armand Aniambossou the, French Ambassador and in attendance were key dignitaries who included; Mr. Robert Kotchani, UNOHCHR Country Representative; Mr. Matia Lwanga Bwanika, LCV Chairperson Wakiso district, Dr. Sylvia Namubiru Mukasa, LASPNET CEO, Ms. Shifrah Lukwago, Commissioner, UHRC among others.

Speaking at the function, the Chairperson of the Wakiso Human Rights Committee, Mr. Kasirye Elly appreciated LASPNET in a special way for the joint collaboration that made the celebrations a reality while Dr. Sylvia Namubiru Mukasa commended the Government of Uganda for adopting and enacting of progressive legal frameworks on human rights such as the National Action Plan on Business and Human rights. The CEO used this platform to urge government to cause for the enactment of the National Legal Aid law.

Further, the LC5 Chairperson Mr. Matia Lwanga informed the public about the challenges faced by the district including limited resources to functionalize the district arms, however, he expressed his commitment towards functionalizing the Wakiso District Human Rights Committee amidst the limited resources.

Similarly, Ms. Shifra Lukwago, Commissioner at UHRC implored duty bearers to promote and protect human rights of all Ugandans.

His Excellency Jules-Armand Aniambassou, the French Ambassador appreciated the organizers of the event and pledged full support of the French Embassy towards the protection and promotion of rights at all levels. He further remarked that the Embassy will be in full support of the future International Human Rights Day.

On the sidelines, Baba TV captured a sensitization clip on human rights which was aired periodically as part of sensitizing the public.

Thus the celebration of the international Human Rights Day helped in bringing together the different actors to reflect on the state of human rights in the country as well as undertake commitments to respond the worrying human rights situation in the country.

### 7.1.5 LASPNET conducts Legal Aid open days

### (a) Legal Aid Open day in Kyegegwa district:

LASPNET with support from the UNDP Spotlight Initiative held a legal aid open day in Kyegegwa district on 25th August 2022 under the theme **"Elimination of** *Violence Against Women and Girls and promotion of Access to Justice for all.*"

The hybrid event was graced by a total of 232 participants (157 Male: 75 Female) including Judicial officers; District officials (such as LCV Chairpersons, DHOs, CDOs); Media among others.

Due to COVID-19 guidelines and following SOPs, the Legal Aid Open day was broadcasted live on both zoom and Britop FM Radio to provide opportunity to the rest of public to hear the proceedings and to call in to ask questions that were answered. Similarly, to ensure a wider reach, Lawyers from LASPs in Western regions were mobilized and dispatched in various sub counties to provide on spot legal advice and counseling to communities.

On the other hand, the function in Kyegegwa was presided over by Her Worship Joy Nambozo, the Chief Magistrate of Kyenjojo district who appreciated LASPNET and UNDP for the kind consideration to take the Legal Aid Open day in Kyegegwa where the demand for legal aid services remain enormous. She also observed that SGBV is on a rise and that it's partly caused by overstaying of children at home in addition to Kyegegwa being a host of Kyaka refugee settlement.

Dr. Sylvia Namubiru Mukasa in her remarks, commended UNDP for supporting legal

aid outreaches which are intended to strengthen access to justice for most poor and vulnerable and echoed the intention of the legal aid open day which was creating awareness on Access to Justice and SGBV in Kyegegwa as one of the Spotlight districts with high prevalence of SGBV.

Speaking on behalf of UNDP, Ms. Annet Mpabulungi Wakabi, the Team Leader Rule of Law and Constitutional Democracy recognized government efforts towards eliminating violence against women and girls in Uganda working under the coordination of Ministry of Gender, Labour and Social Development. She noted that, while a lot of interventions have been implemented, there is still have high prevalence of violence against women and children in the country. In addition, highlighted the uneven distribution of legal aid institutions in the country hence the need to conduct more legal aid outreaches.

While presenting the district status on GBV, Ms. Birungi Agnes, the District Gender Officer noted that by the end of last financial year, the status of SGBV stood at 64.1% mainly comprising of early teenage pregnancies. She added that in the period (July – December 2019), a total of 975 early teenage pregnancies were registered and this increased drastically to 11,504 in the period January to December 2020. She requested participants and the whole district to join hands to fight against GBV among women and children by reporting the2 perpetrators and sensitizing the public about GBV.

The welcome remarks were made by Mr. Joel Magoba, the District Speaker on behalf of the LC 5 Chairman of Kyegegwa district who underscored the need for presence of more Lawyers in the district in order to ensure timely handling of GBV cases which are rampant in the district. Therefore, he requested the CEO of LASPNET to at least consider designating a full time Legal Officer at the District Headquarters to handle clients with legal problems

### (b) Legal Aid Open day in Amudat district

Similarly, the legal aid outreach in Amudat was held on 31st August 2021. The function was presided over by His Worship Sayekwo Emmy Geoffrey, the Chief Magistrate of Moroto, Nakapiripiriti districts. Also in attendance were district officials such as Mr. Lobot Joseph Nangole, the District LC5 Chairman, Mr. Masokoyi Wasswa, the Chief Administrative Officer, DPC Mwesigye James, Dr. Loyce Nangiro, Representative of the DHO, Dr Sylvia Namubiru Mukasa, CEO LASPNET as well as Legal Aid Service Providers and Media.

The event attracted a total of 248 participants (198 Male: 50 Female) who included clients that received legal aid as well as key invited guests. The event was also broadcasted live on Kalya FM.

Arising out this Legal Aid Open day, H/W Sayekwo pledged to expeditiously handle GBV cases before him in both Moroto and Nakapiripiriti by bringing nearer the court to people of Amudat. He therefore noted that in consultation with the district leadership, he would be conducting a Biweekly court sessions intended to reduce on case backlog in the district.

The outcome of these legal aid open days was the increased access to legal information and legal aid to clients with legal problems.

#### c) LASPNET and NSSF extend legal aid to communities and Children at Kabalye Remand home in Masindi District

On the 29th April 2022, LASPNET in partnership with NSSF convened one Legal Aid Open day at Boma grounds and an outreach at Kabalye Remand Home in Masindi district.

The event was organized under the theme *"Promoting Legal Aid Employees' Rights by bringing Justice closer to the People"* and was presided over by His Lordship Hon. Justice Byaruhanga Jesse Rugyema of Masindi High Court Circuit.

The open day attracted a total of 133 clients (85 Male: 48 Female) who sought legal aid services on legal issues affecting their communities especially in relation to land grabbing, corruption, human rights violations and abuses among others.

Also in attendance were justice institutions such as Uganda Prison Services; Judicial Service Commission; Uganda Human Rights Commission and Legal Aid Service Providers who were given opportunity to showcase their services and products. Arising out of the legal aid open day, LASPNET and NSSF were able to extend legal aid services to the people of Masindi.

Similarly the event contributed towards increased awareness and provision of legal services in Masindi where LASPs presence remain unevenly distributed.

### d) Legal Aid outreach in Kasese district and five sub counties

Building on the existing partnership and with additional funds from the UNDP Spotlight Initiative in the year 2022, LASPNET held a legal aid open day in Kasese district aimed at providing legal aid and creating awareness on access to justice and sexual gender-based violence to the communities.

The Legal Aid Open day in Kasese district took place at Rwenzori Square and in five (5) different sub counties of Hima, Kitswamba, Bugoye, Karusandara and Lake Katwe. The event was organized under the theme, "*Elimination of violence against women and girls and Access to Justice for All.*" and was presided over by His Lordship Mugabo Emmy Vincent, the Resident Judge of High Court, Fortportal.

The open day attracted a total of 1,004 (422 Male : 582 Female) at the main square and sub counties to seek legal aid services on legal issues affecting their communities especially in relation to land grabbing, corruption, human rights violations and abuses among others. In attendance were justice institutions such as Uganda Prisons Services, Local Government, Media and LASPs such as ULS, LDC, JCU and UCLF who provided legal support services to clients. Through this legal aid open day, LASPNET and UNDP were able to extend legal services to the people of Kasese.

It also contributed towards increased awareness and provision of legal services in Kasese where LASPs presence is limited.

### 7.1.6 LASPNET commemorates 16 Days of Activism against GBV among Girls and Women

On the 2nd December 2021 LASPNET together with its partners World Vision, Karitas Uganda, Buikwe district leadership joined other stakeholders and launched the 16 Days of Activism campaign under the theme **"Orange the world: End Violence Against Women Now."** The campaign called upon all stakeholders to end GBV in greater Mukono and the country at large.



The Deputy RDC of Buikwe district Mr. Sanon Dhaala officially launching the 16 Days of Activism at Lugazi Town Council.

At the launch, Mr. Osborne Agwii the World Vision Program Manager in Buikwe district appreciated all stakeholders for joining hands to convene the launch of the 16 Days of Activism in Buikwe. He added there has been an increase in teenage pregnancies during the lockdown to 631 cases according to the research conducted by World Vision Uganda in 2021.

Ms. Maria Kaddu, EU Project Coordinator who represented the CEO at the event added her voice to appreciate the district leadership, partners and LASPs for accepting to work as a team during this campaign. According to her, LASPNET and EU, chose greater Mukono to implement the GBV project due to high GBV incidences in that region informed by the baseline report carried out by LASPNET. While addressing the gathering, the District Police Commander of Buikwe District Kakirya Moses, called upon parents to withstand the temptations of marrying off their children under the pretext of absolute poverty instead they should aim at educating their children.

The event was closed by Mr. Sanon Dhaala, the Deputy RDC of Buikwe District, who implored partners, authorities, community leaders and Community Watch Committees to be very vigilant and report cases of child labour within the district. Furthermore, LASPNET identified champions such as High Court Judges, district leaders, women groups, children, security personnel among others to share messages towards commemoration of the 16 days of activism.

To further spice up the campaign, LASPNET identified champions such as High Court Judges, District leaders, Police, CSO Leaders, Women groups, Children, among others to share messages towards commemoration of the 16 days of activism.

### 7.1.7 LASPNET revamps the GBV Mobile Toll-free line

LASPNET in partnership and with support from UNDP Spotlight Initiative, secured six (6) multiple Toll-free lines from UTL to facilitate the provision of on-spot legal aid services in various spotlight districts including Kampala, Arua, Amudat and Kyegegwa.

Furthermore, the GBV Mobile Toll-free lines are manned by five (5) call agents stationed in various spotlight districts who were trained on customer care, client satisfaction and reporting.

A total of 54 cases related to GBV were handled through the GBV Mobile Toll-Free line between May and July 2022.

7.1.8 Bringing Justice closer to the vulnerable through coordination of the Call centre and other innovative approaches

#### a) LASPNET Call Centre continues to provide faster responder & referral services to clients

In the period under review, LASPNET continued coordinating partners such as PILAC, UCU, LDC and ULS who provided call centre agents to man the Call Centre. During this period, a total of 879 (514 Male: 360 Female) clients supported by the Call Centre. Majority of the cases received under the call centre were domestic violence; land and human rights. Noteworthy is that a total of 28 clients called in to appreciate the support offered by the Secretariat through the Agents as well the referral points which is an indicator of satisfactory services rendered under the Call Centre and by the LASPs under referral pathways.

### b) Impacting lives through the LASPNET Situational Room

In the reporting period, the situational room attended to 100 clients were handled (43 Male: 57 Female) under the category of economic (2) and social (58). The above cases were handled with support from LASPs and other institutions such as UGANET, Kisenyi Health Centre III, Haba Na Haba among others.

Furthermore, in a bid to reinforce the work of the Situational Room to respond to the needs of our clients LASPNET on 27th April 2022 received assortment food relief items including 10 duvets and 10 boxes comprised of rice, sugar, salt, wheat, beans and cooking oil from Haba Na Haba under the Muhammed Bin Rashid Al Maktoum Global Initiative in Dubai.

#### c) Coordination of Legal Aid Rapid Response Mechanism

In the reporting period, LASPNET continued to implement the legal rapid response mechanism owing to the increase in the human rights violations especially for youths, HRDs and Activists through providing response to affected persons in accessing justice. It is imperative to note that the project was majorly affected by the continued closure of DGF that initially provided for Lawyers facilitation and coordination costs for rapid response activities.

On the other hand, with support from GIZ, LASPNET coordinated a total of 10 signed up LASPs Lawyers, Paralegals and Private Advocates to provide impromptu rapid response under the GIZ supported fund. Under this, a total of 14 case files with 31 clients (22 Male and 9 Female) were handled and these were mainly related to Violation of presidential directives on COVID 19; Theft; Criminal trespass and domestic violence. The suspects were supported to apply for bail and bond while others were released on caution. Additionally, a few selected Lawyers and Paralegals continued to voluntarily respond to human rights violations and other cases using their bicycles through undertaking police and prison visits within the areas of proximity.

#### d) Responding to Justice Needs though Social Web Application

Related to the above, the Social Web Application received 24 cases out of which 22 were closed while 2 cases were referred to specialized LASPs for further management. Despite this progress, there has been a down ward trend in the utilization of the SWA. This is attributed to the fact that the lockdown was eased hence enabling clients to physically access lawyers in addition to reduction of funding following the continued suspension of DGF.

#### 7.1.9 Sustaining Collaborations and Partnerships to Influence Access to Justice, Rule of Law and Human Rights

Throughout the reporting period, LASPNET ably participated in various engagements organized by member, its partners-both state and non-state actors in a bid to enhance service delivery in the justice sector.

A total of Ninety-Three (93) external membership and partner's meetings were attended by the Board and Secretariat and key among these included the following;

- The Chief Executive Officer participated as a discussant by making a presentation on Perceptions of the public on Administration of Justice at the 23rd Annual Judges Conference at Mestil Hotel on the 31st to 3rd February 2022.
- The Annual JLOS Government of Uganda/Development Partner Review Meeting held on 14th December 2021 at Munyonyo Speke Resort.
- The Annual CSO Leader's reflection retreat convened by UN NGO Forum

from 14th to 16th December 2021 at Jinja Source of the Nile Hotel.

- The International Anti-Corruption Day convened by the IGG and presided over by His Excellency the President of Uganda on 9th December at Kololo Ceremonial Grounds.
- Residential Partners reflection and learning conference organized by IDLO from 1st to 3rd December at Imperial Golf View Hotel, Entebbe.
- The 4th Women Human Rights Defenders Conference convened by Human Rights Centre Uganda on 24th November 2021 where the Chief Executive Officer was a panelist.
- The Roundtable meeting on Justice Accountability Reform Programme organized by EU at Serena Kigo.
- UPR Conference Pre-sessions from 22nd to 25th November 2021 convened by the National Coalition of Human Rights Defenders – Uganda (NCHRD) at Kabira Country Club and Silver Springs Hotel Bugolobi respectively.
- A meeting for the Executive Directors and Chairpersons Space organized by UWONET on the 1st and 2nd June 2022 attended by Ms. Flavia Zalwango, Central Representative for the Board.
- The Chief Executive Officer made a presentation Invitation at the 24th UHRC Annual Report Consultative Meeting presenting on LASPNET's Perspective on Enforced Disappearances in Uganda and the Human Rights Implications in 2021.

7.1.10 Establishment of a Working Group on CSO enabling environment comprising of substantive members who include: CSSA partners, EWMI, NGO Forum as well as State and Non-State Actors to be co-opted such as: Financial Intelligence Authority, Uganda Human Rights Commission, Uganda Law Reform Commission, Ministry of ICT, Ministry of Justice and Constitutional Affairs. ODPP. Human Rights Centre Uganda, Inter Religious Council of Uganda, Uganda Women's Network. National Union of Disabled Persons of Uganda, Network for Public Interest Lawyers, Human Rights Awareness and Promotion Forum, among others. As a result, an online working group meeting was conducted on 12th August 2022 to discuss the status of the 54 suspended CSOs by the NGO Bureau.

In addition to the above and still under the CSSA project, LASPNET together with CCSA partners convened a National Conference on the enabling Environment for CSOs which was preceded by cluster conference meetings held from 26th to 29th July 2021. Ultimately, the Conference was convened by ICNL on 18th August 2021. Following the conference, partners developed an action plan to inform various initiatives to be supported under CSSA.

### 7.1.11 Development Partners Round Table Meetings

LASPNET convened a Round table Development Partners meeting on 18th May 2022 at Sheraton. The meeting was attended by a total of 42 participants (19 Male: 23 Female) who included; Honorary members; Development partners (DGF, ADA, European Union, Freedom House; UNDP & UNODC); National Working Group members and Secretariat staff.

The rationale of this meeting was to provide a status update on the advocacy efforts for the enactment NLAB 2022 as well as present an Advocacy roadmap for the pending advocacy activities for the NLAB in a bid to solicit donor financial and technical support. The event was officiated by Hon. Justice Remmy Kasule who in his key note speech highlighted concerns over the delayed enactment of the NLAB. The partners appreciated the update on progress and the efforts undertaken by LASPNET and GNPF in regards to advocating for the enactment the NLAB into law in addition to pledging their continued support towards the realization of the NLAL.

#### 7.1.12 Strengthening ongoing partnerships and New Development and Strategic Partners

Partnerships with both state and non-state actors continue to facilitate LASPNET in effective realization of its mandate of enhancing access to justice for trhe poor and vulnerable. In the reporting period, LASPNET continued to work with several partners such as HiiL; Barefoot Law; UCBA; NSSF; ULC among others. Furthermore, two (2) new Development Partners came on board to support the Network in addition to the ongoing Development partners.

The projects and support partners are expounded on below;

#### 7.1.13 New Development Partners

#### a) GIZ

In the reporting period, LASPNET on the 2nd July 2021 executed a partnership agreement with GIZ to implement a three months (July to September 2021) project titled **"Strengthening Access to Justice for Human Rights Defenders,** 

#### Activists and Victims of Prerogative Orders through provision of Legal Rapid Response."

Key among the project activities included; a consultant to facilitate Engaging paralegals to undertake prison visits to document and compile lists of HRDs, and victims of prerogative activists orders; coordinate LASPs to provide legal representation for impromptu rapid response cases; convene inception and progress meetings with criminal justice actors and engaging consultants to conduct mini-criminal sessions at the Chief Magistrates Courts of Makindye, Buganda Road and Entebbe where a total of 570 clients were supported to access justice through release on bond, bail and caution.

### b) Hague Institute for Innovation of Law (HiiL)

LASPNET executed partnership with the Hague Institute for Innovation of Law (HiiL) to support the implementation of the HiiL Innovating Justice Programme, a three (3) months (October to December) 2021 project, focused on building the capacity of LASPs on how to integrate evidencebased working in handling and solving of people's pressing family justice problems. The main activities implemented under the HiiL Project included conducting of a capacity building training of LASPs on family justice as well as development of an online platform to aid information sharing of LASPs on family justice issues.

### 7.1.14 Continuation with Existing Partnerships

#### c) European Union

Building on its partnership, LASPNET continued to implement the EU two-year Project titled **"Empowering formal and**  *informal justice system actors to handle and respond to GBV in Mukono; Kayunga and Buikwe districts.*" Some of the main activities implemented under the EU project included development of the GBV Handbook and Manual, conducting of GBV Community Dialogues as well as the GBV awareness days in Buikwe, Mukono and Kayunga districts.

#### d) Australian Development Agency-Avocats Sans Frontiers (ASF)

LASPNET in partnership with Avocats Sans Frontiers (ASF) with funding from ADC continued to implement a three-year (2020-2023) project; **"Protecting procedural and constitutional rights through access to justice."** The project seeks to enhance access to justice and human rights through promotion of procedural rights for pre-trial detainees.

Key among the project activities undertaken in the reporting period include; Coordination of 27 Paralegals/Human rights Monitors and Advocates who have continued to identify and were enter cases into the KOBO Toolbox. A total of 2107 cases have been entered during the reporting period, out these 731 were closed through securing bail, bond and legal advice on self-representation while 541 are pending.

### e) East West Management Institute (EMWI)

In the reporting period, LASPNET continued to implement the USAID Civil Society Strengthening Activity aimed at promoting a more supporting enabling environment that sustains a vibrant civil society for a period of 6 months, April to October 2021. The project is implemented in partnership with International Center

for Not-for-Profit Law (ICNL); Chapter Four Uganda; National Coalition for Human Rights Defenders (NCHRD); and Collaboration on International ICT Policy in East and Southern Africa (CIPESA). The main activities implemented under CSSA include the development of the Training Paralegal Handbook and establishment of a working group on CSO enabling environment.

#### f) Freedom House- RAJA Project

In the period under review, LASPNET continued to implement the RAJA project focusing on enhancing access to justice for the poor and vulnerable in collaboration with various sub group members who include FAPAD, ULS, PILAC and RLP. Some of the activities implemented under the Freedom House project included convening of Mobile Legal Aid Clinics and Breakfast meeting with Committee and Caucus Chairpersons to advocate for the enactment of the NLAB.

#### g) UNDP Spotlight initiative

Building on the exiting partnership with UNDP, LASPNET continued to implement the Spotlight Initiative titled *"Eliminate Violence against Women and Girls."* The Spotlight Initiative is aimed at capitalizing on existing Programmes and interventions addressing Harmful Practices, Violence against Women and Girls and Sexual Reproductive Health Rights in Uganda.

Some of the activities implemented under the Spotlight project included; Conducting of Legal Aid Open days and Operationalization of the GBV Call Centre.

### h) International Development Law Organization (IDLO)

The IDLO project titled; **"Supporting** Legal Aid Service Providers (LASPs) to enhance access to justice for the poor, vulnerable and marginalized in Uganda," is ultimately aimed at promoting community justice initiatives. Some of the main activities implemented under the IDLO project included conducting advocacy meetings for the NLAB; Supporting IIMS upgrade and support visits; conducting regional dialogues for formal and informal justice actors among others.

### i) Catholic Organization for Relied and Development Aid (CORDAID)

LASPNET with funding from CORDAID under its project titled; "Integrating Mental health and Psychosocial Support CORDAID's Thematic in (IMPACT) **Project**" in partnership with Transcultural Psychological Organisation (TPO). Some of the activities implemented under the CORDAID project included conducting of Local District and National Advocacy dialogues on Mental Health and Psychosocial support.

#### (j) OXFAM- VOICE Linking and Learning

LASPNET continued to coordinate Strategic Link to implement the OXFAM funded linking and learning project. The main activities implemented under the project included the continued maintenance of the digital platform and supporting grantees to upload content for Voice digital platforms; conducting of Kick Off Meetings for the 9 new voice influencing grantees at Kabira Country club hotel on the 14th and 15th February 2022; conducting of three (3) online linking and learning meetings with the three (3) grantees and undertook onsite mentorship visits to the grantees.

### (k) Democratic Governance Facility (DGF)

In the reportina period. LASPNET continued to receive institutional support to implement the DGF project titled; "Strengthening Collaborative Advocacy Platforms to Enhance Rule of Law, Legal Aid and Access to Justice for the Poor, Vulnerable and Marginalized in Uganda." Therefore, LASPNET utilized the DGF costed extension project to implement mainly desk work activities: undertake the development of the DGF end of project evaluation report, pay staff salaries as a retention strategy as well as facilitate overhead costs including rent and other utilities.

### 7.2. RESEARCH AND KNOWLEDGE MANAGEMENT

LASPNET has continued to strengthen its evidence-based research and knowledge management thematic component. In the reporting period ending July 2022, with support of development partners who included DGF, IDLO, EU and EMWI, LASPNET produced a total of 5 evidencebased researches on Access to Justice; Rule of Law and Human rights and published standardized Manuals and Service Protocols in improving service gaps in legal aid service delivery.

These researches and reference tools continue to strengthen evidence-based advocacy by key in key stakeholders in the governance and security sector, Academia, Development partners, media and the public in addition to strengthening standards in service delivery among the LASPs. Some of the researches and reference tools include;

### 7.2.1 Annual Access to Justice Trends Analysis research (2020)

In the year 2020, LASPNET commissioned the development of the Annual Access to Justice Trends Analysis Research 2020 in December 2020. The research aimed at documenting emerging trends in delivery of access to justice in the wake of COVID-19 and impact of the new normal on Access to Justice as well as opportunities to inform policy recommendation. Upon finalization by the consultant on 6th January 2021, the report is now available for use and dissemination to the stakeholders.

### 7.2.3 Publication of the Second Edition of the Paralegal Voice Magazine

Following a compilation of Paralegal success stories, and testimonies in enhancing community justice amidst the COVID-19lockdown, on the 27th August 2021, LASPNET published the 2nd edition of paralegal magazine which highlighted success stories and policy recommendations to improve paralegal work. The Magazine was disseminated online to different members who include among others LASPs, Development partners and Community paralegals.

#### 7.2.4 Development and Launch of an Investigative Story on Corruption titled "Defiled by My Father: A quest for Justice."

In the year 2020, LASPNET commissioned the development of a documentary story on Corruption to expose loopholes in the criminal justice system especially Police and ODPP induced by systematic corruption tendencies and maladministration. The documentary was validated by the Advisory Committee on Governance and Monitoring Corruption in JLOS and finalized was finalized by the Consultant. Upon finalization, it was released on 7th October 2021 for public viewership via various social media platforms including Twitter and Facebook. Key stakeholders such as Uganda Police Force and the Media were involved in the online launch and pledged to follow up the case to ensure that justice is served for the victim. The online launch was widely covered by both the mainstream media and social media under the hashtag #DefiledByMyFather.

Subsequently, the story was launched on 25th October 2021 at Golden Tulip and this launch was graced by Dr. Rosiwtha Kremser, Head of Office of Austrian Embassy; Dr. Miria Matembe, a Senior Citizen and CCEDU Chairperson; Ms. Samali Wakholi, Asst. DPP and Dr. Sylvia Namubiru Mukasa, the LASPNET CEO. Arising out of this launch various stakeholders pledged to leverage their mandates to fight GBV and institutional corruption within justice institutions.

#### 7.2.5 Development of the Training Handbook for Paralegals and CSOs in enabling Environment

LASPNET with support of a consultant developed a training handbook for paralegals and CSOs on promoting an enabling environment aimed at supporting Paralegals and CSOs on how to navigate the restrictive operating environment.

The handbook was validated on 22nd November and 15th December 2021 respectively. Upon finalization, the handbook was published and a digital version was disseminated online to the stakeholders. As result, the handbook is currently used as a reference tool for equipping paralegals with knowledge and skills to navigate the restrictive CSO operating environment.

# 7.2.6 Translation of the Paralegal handbook in Two languages (Atesot & Runyakore)

LASPNET undertook translation of the Paralegal Handbook originally developed with support of DGF in 2018. The translated Paralegal handbook was translated in two languages of Atesot and Runyakore. The rationale for translation of these Handbooks is to enhance community justice so that informal actors such as community paralegals can comprehend the legal and procedural aspects for handling societal problems.

# 7.2.7 Publication of the Translated IEC Materials on Access to justice (posters & stickers):

Further a total of 2500 Translated Paralegal IEC Materials on Access to Justice in languages of Runyakore and Atesot were published on 26th February, 2022. So far, a total of 170 fliers and car stickers have been disseminated.

#### 7.2.8 Development of the GBV Training Manual and GBV Handbook for informal justice system actors

LASPNET engaged a consultant to develop GBV training Manual and GBV Handbook for informal justice system actors. The knowledge products covered the concept of GBV, its causes and manifestations as well referral pathways. These were validated and later disseminated to various partners.

### 7.2.9 Development and dissemination of the EU project success story magazine.

LASPNET developed the EU project magazine titled "Joining Hands to fight GBV; The Community Change Stories: A Documentation of Stakeholders' and Survivors. The magazine highlighted stakeholders' and partner voices about the EU-GBV project as well as its registered impact, success Stories from beneficiaries in the project districts of Mukono, Kayunga and Buikwe Districts. It was launched and disseminated during the 3 GBV awareness days that transpired in the project districts on the 19th, 26th May and 2nd June 2022 respectively.

#### 7.2.10 Desk research on topical issues prepared to contribute towards Access to Justice and Rule of Law

In the reporting period, LASPNET developed three (3) presentations and position papers on Access to Justice which were shared in different fora. These included;

- At the 23rd Annual Judges Conference held on the 23rd February 2022 at Mestil Hotel, the CEO as a panel discussant presented a paper on "Public perceptions on the Administration of Justice in Uganda." The depth of analysis and research in this paper was overwhelmingly appreciated by the Judiciary to the extent that it was uploaded on the Judiciary website.
- A paper on the implication of the Speaker's ruling on the Business of the 10th Parliament delivered during an online webinar meeting convened by CEPIL on the 6th October 2021 in which the CEO was a presenter.
- A paper on the analysis of implementation of the CEDAW and Maputo Protocol in Uganda delivered at the UWOPA meeting
- A presentation was prepared on access to justice for Women Human Rights Defenders delivered by the

CEO at the HRD Women conference convened by HRCU

 A position paper on the proposed Bail, State Brief and Sentencing guidelines was developed by LASPNET working closely with the Office of the High Commissioner on Human Rights (OHCHR) and its member LASPs under the criminal justice cluster i.e. FHRI, CJAF, IWILAP and CLA and submitted to the Judiciary Rules Committee and the Chief Justice on 2nd March 2022.

### 7.3 LOBBY AND ADVOCACY

In the year ending July 2022, LASPNET with support of development partners who included DGF, EU, IDLO, GIZ, Freedom House and ADA implemented various advocacy interventions aimed at enhancing Access to Justice; Human rights and Rule of Law as heighted below;

# 7.3.1 LASPNET Coordinated the Universal Periodic Review Cluster on Access to Justice

Following submission of the Access to Justice Cluster on the 14th July 2021 via the UPR Mechanism Portal, LASPNET participated in a four-day Uganda UPR Conference Pre-sessions from 22nd to 25th November 2021 convened by the National Coalition of Human Rights Defenders -Uganda (NCHRD) in collaboration with the United Nations Office of the High Commissioner for Human Rights [OHCHR]. Defend Defenders and Centre for Health and Human Rights and Development (CEHURD) at Kabira Country Club and Silver Springs Hotel Bugolobi respectively. The conference was held under the theme "Citizen Centered Universal Periodic Review" and was aimed at generating consensus on Ugandan CSO Thematic recommendations.

The conference involved structured dialogue with Diplomatic Missions who comprised of representatives from the Embassy of Netherland, Sweden, Demark, Italy, Belgium, Austria and European Union. The government was represented by a delegation from the Ministry of Foreign Affairs.

In addition, presentations were made by the 22 thematic cluster heads with emphasis to generate thematic agreed recommendations. In particular, Dr. Sylvia Namubiru Mukasa made a presentation for the Access to Justice Cluster in which she underscored the need for Government to enact the National Legal Aid Law which recommendation stems from the 2011 UPR recommendation.

#### 7.3.2 Strengthening Access to Justice for HRDs and Activists through Rapid Response and Advocacy under the GIZ project

On 17th September 2021, LASPNET convened one inception meeting with key stakeholders comprising of Chief Magistrates of Buganda Road H/W Okello Miriam Ayo, Chief Magistrate of Makindye; H/W Basemera Sarah Anne and Entebbe Magistrates Court H/W Nakitende Juliet; Resident State Attorneys; Development partners, Advocates and Paralegals.

The meeting was attended by 33 (13 Females, 20 Males) participants and arising out of this meeting, the stakeholders were briefed about the project objectives, methodology and expected outputs and outcomes. Among the key outputs that emerged from the inception meeting include; the overwhelming commitment of the Judicial officer; Lawyers and State Attorneys to support the convening of the mini-criminal sessions in the Chief Magistrate Courts of Buganda Road, Makindye and Entebbe, formation of a WhatsApp group by the Secretariat to ease coordination of the mini-criminal-sessions.

#### ii) Mini Criminal Sessions Conducted

A total of 3 mini-criminal sessions conducted at Buganda Road; Entebbe and Makindye Chief Magistrates Courts on 26th July, 7th and 8th October respectively. As a result, 570 (545 Male: 25 Female) were supported to access justice through release on bond; bail and caution.

# 7.3.3 GBV Community dialogues held in Kayunga, Buikwe and Mukono Districts under the EU project

On the 1st October 2021, LASPNET convened a Community Dialogue with Justice Actors and Local Government

leaders within the target project districts of Buikwe, Kayunga and Mukono districts respectively. The dialogue in Kayunga was attended by several dignitaries including H/W Sanula Namboozo, Grade One Magistrate; Mr. Ronald Mukoza, the Deputy Resident District Commissioner, Ms. Roseline Adongo, the Chief Administrative Officer Ahmed Matovu and the District Health Officer.

At the dialogue several dignitaries made remarks which underscored the increase in GBV cases manifesting in form of domestic violence, rape, defilement and child related offences such as early marriages as a result of Covid-19 thus called upon stakeholders to join hands and fight the vice.

Mr. Ronald Mukooza, the Deputy RDC appreciated LASPNET of Kayunga for considering to implement the GBV Campaign in Kayunga district through conducting a baseline survey to shape the project interventions while emphasizing the need for more awareness raising on GBV especially in Sub counties such as Bbaale where the vice is more rampant. He acknowledged the issue of economic empowerment as advanced by Dr. Sylvia as a backbone to development and called upon the community members to engage in government programs such

as the parish development model and "emyooga" a presidential wealth creation initiative that is aimed at eradication of poverty in communities H/W Nambozo Sanula, the Grade One Magistrate of Kayunga, remarked that Gender-Based Violence is deeply rooted in gender inequality, and continues to be one of the most notable human rights violations within all societies. "Gender-based violence is directed against a person because of their gender, both women and men experience gender-based violence but the majority of victims are women and girls." It is therefore not surprising that whenever GBV is mentioned, what comes to everybody's mind is violence against women. So, using the 'genderbased' lenses in delivery of justice is important as it highlights the fact that many forms of violence against women are rooted in power relations between women and men" she explained.

While closing the dialogue on behalf of the LC5 chairman and the District Woman counsellor of Kitimbwa Sub- County Ms. Namukose Fatumah condemned parents who reject the girl child because of early pregnancies. She gave an example of her own daughter whom she neglected out of anger after getting pregnant while at school. However, after being cajoled by concerned people, her daughter went back to school and graduated in Social Work and Social Administration. She concluded by encouraging parents to always give a second chance to young impregnated girls by taking them back to school instead of subjecting them to child neglect.

Similarly, on 14th October 2021 LASPNET held another Community Dialogue at Buikwe District Headquarters where Ms. Jane Francis Kagayi, the RDC of Buikwe expressed her support to LAPSNET in responding to GBV.

She noted children get involved in bad behaviors whenever their parents are not at home or being neglected by their fathers and hence, they end up becoming teenage mothers. She called upon all leaders at different levels to work together to handle GBV in all aspects. "GBV should be taken as a key concern and as representatives of the president in the district, we will provide all the necessary support that is needed to end GBV in the district" she said.

Relatedly, on 19th October 2021 LASPNET held another Community Dialogue at Mukono District Headquarters. The District Councilor Mukono District Ssegavu Lukeman. appreciated LASPNET on behalf of the District Chairperson for the work done in the selected Sub Counties within Mukono during the GBV community outreaches held on 18th October, 2021. He underscored the need to use the Dialogue as a platform to learn more about LASPNET's work, as well as GBV and how to respond to it.

While presenting and sensitizing participants on the impact of GBV in land, succession and inheritance, the

Resident Judge of Mukono High court circuit His Lordship Justice David Batema, commended Dr. Sylvia Namubiru Mukasa for the advocacy work she is doing and for standing out among others to fight for human rights and mostly women's rights. He pulled out four (4) critical points about gender perspectives in Uganda namely; Informed laws made by Parliament, informed by culture norms, by religion and lastly by training and orientation.

His Lordship appealed to members to give all children equal opportunities, in school, work and wealth whereby if women and girl children are being given land, it brings an opportunity for them to gain wealth and economic empowerment. To him, for a society to be more developed, both men and women should work together.

In her closing remarks, the RDC of Mukono, Ms. Fatumah Ndisaba, revealed how some environments are not friendly to the opposite sex.

### 7.3.4 Convened a Local District Advocacy Dialogue on MHPSS:

LASPNET with support from CORDAID conducted this event on 25th October 2021 in Terego district under the theme effective "Exploring strategies for integration of Mental Health and Psychosocial support into Access to Justice and Health services for Sexual Gender-Based Violence Survivors in Refugees settlements." The dialogue was attended by 43 participants (29 Male: 14 Female) including the Judiciary; District Officials; Health practitioners; LASPs and Media. Furthermore, the strategies mooted by the participants at the dialogue included; the need to mainstream mental health among justice actors; strengthen referral pathways between legal aid service

providers and health centres; lobbying for increased budget allocation for CSOs and Health centres to handle mental health issues; undertaking capacity building trainings for LASPs lawyers and Health practitioners; conducting awareness campaigns on MHPSS.; mapping of areas that are highly prone to mental health related cases as well as establishment of GBV survivor shelters for rehabilitation.

Similarly, on 29th October 2021, LASPNET held a National Conference on MHPSS under the theme; "Strengthening Mental Health Psvchosocial Services for SGBV Survivors in Uganda; Reflecting on the Milestones Challenges and **Opportunities**," at Hotel Africana. The conference aimed at collectively aeneratina advocacy interventions towards integrating MHPSS into response mechanisms for SGBV Survivors. The conference was attended by 76 participants (42 Male: 34 Female) from Ministry of Health; Academia; LASPs; Media among others. The key recommendations arising from the conference included: the need to consider advocacy for policy amendments on legal and policy frameworks to bring them into conformity with the different cultural context in response to GBV; the need for service providers to use a multifaceted approach in responding to issues of mental health and as a way of contributing to reduction of GBV; capacity
enhancement and strengthening of all stakeholders i.e. Police, Judicial officers; LASPs, Media, Community, Legal Officers, Mental health practitioners in responding and handling GBV and establishment of a wellness centers for service providers that support GBV survivors among others.

## 7.3.5 Conducted 3 GBV Awareness Days in Mukono, Buikwe and Kayunga districts

The GBV Awareness Days were held with an aim of creating awareness of GBV as well as standing in solidarity with the survivors. These took place on 19th May 2022 in Buikwe district, followed by Kayunga on 26th May and Mukono on 2nd June 2022. The Awareness Days were part of the interventions under the EU supported two-year (2020-2022)project titled "Empowering formal and informal justice systems to respond and handle Gender-based Violence (GBV) in the districts of Mukono, Kayunga and Buikwe."

The events intended to strengthen GBV response and prevention mechanisms as well as increase awareness about GBV in the districts were celebrated under the project campaign slogan *"Let us join*"

hands to fight GBV among women and children" literally translated as "Tukwatire wamu okumalawo okukabasanva abakyala na'baana.," In total the GBV Awareness days attracted a total of 869 participants (Males: 395 Femalse:474 including children) who included project partners including UGANET, AAV. JCU, UCLF and IWILAP, JLOS officials, paralegals and GBV Community Watch Committees (CWCs) and GBV district partners such as World Vision, Makerere Walter Reed Project (MUWRP), Loham Children Ministries as well as District leadership from the project target districts.

Among the Key note speakers and guests during the activities included Hon. Justice David Batema, Resident Judge Mukono High Court Circuit, Hon. Justice Eva Luswata as well as Mr. Nicolas Gonze the EU Head of Section, Governance and Social Inclusion who represented the EU. These in unison applauded LASPNET and the district leadership for taking tremendous strides in GBV response and prevention in the project focus districts.

The awareness days commenced with a series of activities aimed at raising GBV awareness in the districts including the airing of radio DJ mentions and jingles on community radios, the movement of a mobile caravan, a fitness crusade where the crowd puller, Mr Golola Moses entertained and also sensitized the community about GBV as well as matching through the districts led by a brass band coupled with skaters and bikers who disseminated flyers and posters with GBV awareness messages to the community members. The activities were crowned off with the launch the project success story magazine titled "Joining Hands to Fight GBV: Community Change Stories" and inspection of stalls for LASPs and GBV partners.

Conclusively, the GBV awareness days re-echoed the manifestations and effects of GBV in Buikwe, Kayunga and Mukono districts, highlighted the plight of GBV survivors, raised community awareness on GBV through various platforms such as the justice system actors and media, mobilized the public to shun GBV and created public awareness about the project interventions and milestones. The public was hence empowered with adequate information to continue reporting incidences of GBV to mandated institutions and LASPNET.

## 7.3.6 Conducted Lobby and Advocacy Forums

ASF in partnership with **I ASPNFT** coordinated and participated in three local advocacy forums for Arua, Gulu and Kitgum and Masindi to deliberate with Criminal Justice Actors, Local CSOs and partner LASPs on emerging issues under the PTD project so as to inform policy and practice change within the criminal justice system. The Local Advocacy forums took place on 22nd, 24th November 2021 and 30th May 2022 in Arua at Berri Cottages, in Gulu and Kabalega Resort in Masindi respectively. These meetings were attended by Chief Magistrates, Representatives from the Uganda Police Force, Uganda Prison Service, Legal Aid Service Providers and Private practitioners from the districts.

Some of the issues raised at the forum that continue to bedevil the justice system include continued arrests of suspects before investigation; limited awareness about bail/bond and its application; illegal detention of civilians in Military Court martial among others. In the same vein, stakeholders made various recommendations such as the need to conduct more Local Advocacy Forum (s) to discuss issues of PTD as well as the need to consider opening up more LASPs within Masindi.

**7.3.7 Coordinated the convening of one Mobile Legal Aid Clinic (MLAC)** on 14th April 2022 in Kyangwali refugee settlement which benefitted 150 (78 Female: 72 Male) participants out of which 135 received legal assistance provided by PILAC students and RLP Lawyers community and children. The MLAC enabled the communities to be sensitized on SGBV, Access to Justice for refugees and referral pathways among others. Following the MLAC, one radio talk show was held on KKRC radio to create more awareness on access to justice and rights for refugees.

Furthermore, LASPNET coordinated the convening of one Community Dialogue by FAPAD at Lira Sub-county Headquarters on 24th April 2022 to deliberate on key access to justice issues affecting women, men, youth and children. During the community dialogue, a total of 104 participants received legal aid services, psychosocial support services and referrals. In the same vein, one radio talk show was held on QFM and it covered topics such as child sexual abuse, GBV, child abuse, land rights and other emerging issues arising out of the community dialogue. The PA- RAJA attended and represented LASPNET at the event. Also, FAPAD provided legal aid support to 100 (30Male: 70Female) survivors of child sexual abuse in Lira. This activity has increased child rights protection in Lira.

## 7.3.8 Status update on the Enactment of the National Legal Aid Law

In the reporting period, LASPNET held 9 strategic meetings on the Legal Aid Law. Key amongst them included; the orientation of the newly identified Mover of the NLAB held on 20th August 2021; residential Meeting to refine the NLAB held on 5th and 6th November 2021 at Garuga Country Lake resort; debrief strategic meeting with Greater North Parliamentary Forum(GNPF) on 5th May 2022 at Piato Restaurant; reflective meeting with the Legislative and procedural department of Parliament on the 29th September 2021; debriefing meeting on the status on reintroduction of the new Legal Aid Bill to Parliament with the Mover, Seconders and GNPF on 4th March 2022 at Piato Restaurant: stakeholders consultative meeting on the NLAB 2022 held on 30th May 2022 at Hotel Africana and orientation of the Caucus Committees and Chairpersons held on 21st June 2022. All the above meetings provided opportunity for all the stakeholders and policy makers to review the bill and harmonize the Clauses that would stall its progress before presentation of the first reading in Parliament.

Notably, the Orientation meeting of the new Hon. Asuman Basalirwa led by the Chairperson from GNPF as well as Lead draft counsel John Tamale met the newly identified mover and briefed on the ongoing advocacy and next processes of the NLAB.

Subsequently, on the 16th September 2021, the Late Hon. Speaker of the 11th Parliament, the Rt. Hon Jacob Oulanyah pronounced a directive that led to the suspension of all pending legislations by the 10th parliament including the NLAB, 2021. This called for the drafters and Members of Parliament to re-strategize on how to re-introduce this Bill in Parliament. On the 29th September 2021, the new Mover Hon. Silas Aogon the Kumi Municipality MP and Chairperson GNPF attended a

reflective meeting with the members of the Legislative and Procedural Department to discuss the status of the NLAB 2021. The meeting provided a platform for the partners i.e. LASPNET and the GNPF to share its expectations; hear the views and the support needed from the Legislative and Procedural department of Parliament in regards fast track the enactment of the National Legal Aid Bill, 2020.

Similarly, on 5th and 6th November 2021 a residential meeting with the drafter, movers and a select members of the Legal Aid Think Tank (National Working Committee) was convened to receive the overview of the revised National Legal Aid Bill as well as obtain members' input and agree on the next steps.

As a result of the above continued engagements the Mover Hon. Silas Aogon, Chirperson and Member of Parliament, Kumi Municipality on the 9th February 2022, presented a motion before Parliament and was granted leave of Parliament to prepare and introduce the Private Members Bill for the first reading.

## 7.3.9 Leveraging on Cluster meetings to support research and Advocacy

In the reporting period, two cluster meetings were convened as follows;

## a) Convening of the Social Justice Cluster Meeting

On the 4th March 2022, a social justice cluster meeting was convened virtually to discuss the plight of migrant workers to the Middle East for purposes of developing an advocacy position paper and petition addressed the Saudi Arabian Embassy in light of the prevailing human trafficking cases of Ugandans in the Gulf States. However this actualization of the petition remained pending as at the close of the year under review, although the issues of labor externalization and tracking remain a pertinent human right issue.

Subsequently, the membership working group and Rapid Response Lawyers developed an online and physical petition calling upon H.E the President to consider re-opening DGF. The petition underscores the losses made ever since the closure of DGF in regards to job creation, revenue and social justice among others. The online petition has since collected 532 signatures whereas the physical petition is pending submission to the President through the office of the Speaker of Parliament.

## 7.3.10 Access to justice, Rule of Law and Human Rights enhanced through media and related information forums

LASPNET has continuously utilized various media platforms including: Newspapers; Radio and TV to educate, sensitize and advocate for Access to Justice; Rule of Law and Human Rights especially for the poor and vulnerable Platforms. The media engagements captured during the reporting period include the following;

## 7.3.10.1 Newspaper publications

The CEO provided a commentary interview on the current state of human rights and freedom of expression in the London-based magazine known as Index on Censorship.

Furthermore, the Lobby and Advocacy Officer wrote an opinion article on torture which was published in the Independent Magazine on 24th February 2022. The article can be accessed through the link:https://www.independent.co.ug/ increasing-torture-in-detention-cases/ In addition to the above, on the 27th September 2021, two Newspaper pull outs were published paralegal stories in both New Vision and Bukedde newspapers. The pull outs are showcased the work of paralegals in enhancing community justice; highlighted challenges faced by paralegals as well as offer policy and structural recommendations to improve and recognize their efforts.

## 7.3.10.2 Media publicity during LASPNET events

Having stayed relevant on access to justice, human rights and rule of law issues, LASPNET enjoyed free media services in the local dailies and online newspapers. In the reporting period, a total of 78 media coverage and mentions were captured reporting about LASPNET's work and events especially during the 16 Days of Activism; Conferences and Trainings, Annual GBV.

Awareness Days in Buikwe, Kayunga and Mukono, Masindi and Kasese Legal Aid Open Days and the 7th CEO's Forum.

## 7.3.10.3 Press Statements released in the period

In the reporting period, on the 6th June 2022, LASPNET developed one press statement condemning the harsh and selective bail conditions by some Judicial Officers particularly at LDC and Buganda Road Courts. The statement also hinted on the frustrations encountered by opposition MP (Hon. Anne Ebaju) and Deputy Lord Mayor Hon. Doreen Nyanjura in securing bail and therefore called for their immediate release.

The statement made various recommendations including the need for Judiciary management to prevail over the judicial officers who misuse their discretion

to issue harsh bail conditions with the intent of failing justice to the accused persons as well as the need for the prosecution to respect the right to bail and desist from objecting to bail even when offences are bailable and suspects have produced requirement pre-requisite to grant of bail. As a result, on 7th June 2022 the suspects were released.



## 7.3.10.4 The A2J & Human rights Petitions & Position papers

During the reporting period, LASPNET prepared two petitions as highlighted below;

- 2nd March On 2022. working closely with the Office of the High Commissioner on Human Rights (OHCHR) and LASPs under the criminal justice cluster i.e. FHRI, CJAF, IWILAP and CLA prepared and submitted a position paper to the Judiciary Rules Committee on the proposed Bail, State Brief and Sentencing guidelines and the Chief Justice. The crux of the paper was to share views of CSOs on human rights concerns in the proposed Bail, State Brief and Sentencing guidelines.
- An online petition calling upon H.E the President to consider re-opening DGF. The petition underscored the losses made ever since the closure of DGF

in regards to job creation, revenue and social justice among others. The online petition attracted a total of 532 signatures and could have reached the Head of State thus informing his decision to lift the ban on DGF.

### 7.3.10.5 Radio Talk shows

A total of 33 radio talks shows were held to educate the public on various access to justice and human rights issues such as GBV, and EU GBV awareness days, NLAB, legal aid models developed by LASPs and DGF reopening elucidated below;

- The CEO appeared on Prime Radio on 06th September 2021; Impact FM (Uganda Eyogera Talk show) on 29th September 2021; KFM VPN morning talk show on 11th December 2021
- Two regional radio talk shows on KKCR FM and Akaboozi FM were held on 30th and 31st May 2022. The talk shows featured representatives from LASPs i.e. World Voices Uganda and Muslim Center for Justice and Law who discussed their cost effective legal aid models which include the Bataka Court model and E-Law/SMS Platform. The talk shows were purposed on creating awareness as well as popularization of legal aid models developed by LASPs.

## 7.3.10.6 Television Talk shows

In the reporting period, 34 TV talk shows were conducted under the partnership with various media houses;

# 7.3.10.7 Contributing to a Reduction of corruption in JLOS through monitoring corruption and implementing the "Break the Silence Campaign."

With oversight support from the Advisory Committee on Monitoring Corruption in the JLOS, LASPNET continued to implement the Corruption Project through documenting incidences of corruption and good practices within the three JLOS institutions and ended on 30th April 2021.

This activity was however hampred following the end of the project. Whereas monitors undertook to provide voluntary services to continue documenting information to enable LASPNET generate periodic institutional reports to the JLOS institututions, there was slow pace of generation of information therefore no institutional reports were submitted to the respective institutions. Nonetheless a project impact report was submitted to the Governance and Security Program formerly known as JLOS on the 13th Sepetember 2021 and the project findings were captured in the JLOS Annual Performance Report 2020/2021.

Consequently, the Network continued to leveraging on the Break the Silence on Corruption. In the reporting period, the Campaign was implemeted through dissemination of Anti-Corruption Posters to the public at various events organised and participated in by LASPNET and a total of 2,200 posters on anti-corruption in the languages of English, Lugbara, Itesot, Luo, runyakore were disseminated during such as legal aid open days, commemoration of human rights days, GBV annual awareness days among others. As a result, the community has been empowered to report corruption cases to the various anti-corruption bodies such as Police; Judiciary and ODPP.

## 7.4 INSTITUTIONAL STRENGTHENING AND CAPACITY DEVELOPMENT

LASPNET has continued to enhance standards and strengthen the institutional development of the Secretariat and its member organizations. This was done through capacity-building initiatives for members; some of these include; Institutional meetings, IIMS utilization, Planning and Retreats. Below are some of the key achievements.

## 7.4.1 Evaluation of the Strategic Plan 2015/20 and Development of the new Strategic Plan 2021/25

At the expiry of the Strategic Plan in June 2020, LASPNET commissioned consultants to undertake an evaluation of the expired strategic plan and develop a new Strategic Plan 2021/25 to guide the interventions and programming of the Network in the next five years. The evaluation report and Strategic Plan were validated on the 9th July and approved by the Board on 30th July 2021 and officially launched on 22nd October 2021 at the Annual General Meeting (AGM).

The New Strategic which focuses on four critical pillars of Research and Knowledge Management, Lobby and Advocacy, Networking, Coordination and Partnerships as well as Institutional Capacity Building.

## 7.4.2 LASPNET convenes the 7th Annual CEO's Forum

With support from the International Development Law Organization (IDLO), the 7th CEO's meeting was held on 13th April 2022 at Hotel Africana under the theme **"The role of LASPs in enhancing sustainable Legal Aid Service provision** 

*in Uganda.*" The meeting was graced by Hon. Justice Irene Mulyagonja, Judge Court of Appeal and Chairperson Uganda Law Council was attended by 84 (47 Male and 37 Female) participants drawn from the Parliament; IDLO; GNPF and LASPs such as ULS, FIDA, FHRI, WVU; LDC; GNPF and Media.

The meeting provided a platform for organizational heads of LASPs to deliberate on a wide range of issues pertaining access to justice and legal aid service delivery particularly topical and or tenacious matters related to sustainability of the legal aid.

The meeting also comprised panelists including; Ms. Diana Angwech, the Vice President of ULS who took the members through ULS' mandate in addition to stating that ULS is supportive of the NLAB since its intended to close the access to justice vacuum; Ms. Suzan Baluka, Senior Legal Advisor Strategic Litigation at FIDA emphasized the need to include community paralegals into the draft bill as well as undertake evidence-based media stories that underpin the need to fast track the enactment of the NLAB 2022. Furthermore, Dr. Sylvia Namubiru Mukasa, LASPNET CEO argued that the enactment of the Legal Aid Bill is long overdue amidst limited political will since the National Legal Aid Policy remains stuck at cabinet level since 2008. She therefore urged

government to at least gift Ugandans with this law if socio-economic development is to be realized as envisioned under NDP. The meeting also provided opportunity for recognition of the two Advocates who included; Counsel Gawaya Tegulle and Eron Kiiza for their outstanding contribution to the promotion and protection of Human Rights through Public Interest Litigation in Uganda. In addition, Dr. Sylvia Namubiru, the CEO of LASPNET and Ms. Adriko Lillian, CEO of FIDA Uganda were also appreciated by LASPNET Board after the pair was recognized by Courtroom Mail as among the most 100 Africa's Influential Women in Africa in the Legal Profession.

The meeting was crowned off by the Chief Guest Her Lordship Justice Irene Mulyagona who commended LASPNET for its visibility and standing the test of time from when it was conceived. She informed the meeting that LASPNET remains dear to her having been one of its founder members. She appreciated the CEO for holding the fort and ensuring that LASPNET is one of the most recognizable Networks in Uganda. She promised to add her weight to advocacy efforts for the enactment of the NLAB. As the incoming Chairperson of the Uganda Law Council, she was happy and welcome to the proposal of ULC at the helm of coordinating legal aid service provision. Arising out of the meeting was the generation of an Advocacy Road Map that spells out the various advocacy interventions to be undertaken by LASPNET and its members to fast track the enactment of the NLAB 2022 was developed.

## 7.4.3 LASPNET convenes Annual Pre-AGM Access to Justice Conference.

Prior to the Annual General Meeting, on the 21st October 2021, LASPNET held its Annual PRE-AGM in form of an E-learning session under the theme: **"Growing and Sustaining a Resilient Legal Aid Sector in Uganda."** The session was informed by the survey findings on the impact of COVID 19 on LASPs.

The E-learning session provided LASPs with an opportunity to learn innovative strategies for remaining innovative and resilient amidst the challenging CSO terrain in Uganda. During the session, members appreciated the support rendered by LASPNET towards building their capacity to effectively deliver on their mandates, especially under the EU project which is being implemented in Buikwe, Kayunga and Mukono districts.

The meeting was attended 22 participants (9 Male: 13 Female) from UCLF, FIDA, AVV, MCJL and ACTV and facilitated by Ms. Christine Birabwa, the Managing partner at Praxis Conflict Centre whose presentation focused on growing and sustaining resilient Legal Aid Service Provision and; Ms. Grace Nayiga, the Head Legal Aid and Community Justice at UGANET shared experiences on how to remain relevant and innovative during the pandemic.

## 7.4.4 LASPNET holds its 12th Annual General Meeting

The Network convened its 12th Annual General Meeting on the 26th October 2021 was held both virtually and physically at LASPNET Secretariat in which the New Strategic Plan 2021-2025 for the Network was launched.

The AGM was attended by a total of 42 participants (20 Female: 22 Male) who comprised of Board of Directors, LASPs and Honorary Members who included Hon. Justice Remmy Kasule; Ms. Theo Webale, Mr. Aaron Besigve. The matters presented for consideration at the AGM included: The Chairperson's Report and Annual Report of 2020-2021; the Membership Report of 2020 - 2021 with 3 motions on Admission of new Members: Deregistration of Members and Hold of a Virtual AGM, Expansion of membership and Subscription as well as election of Office Bearers. Other matters included the Treasurer's Report and approval of Audited books of accounts of 2020-2021, among others.

During the AGM, Hon. Justice Remmy Kasule presided over the launch of the new Strategic Plan 2021-2025. Members and Secretariat staff appended their signatures as a sign of commitment towards implementation of the Strategic Plan.

Key outcomes of the AGM meeting among others comprised of admission of two new members who are: Center for Health, Human Rights and Development (CEHURD) and Urban Refugee Rights Program (URRP); relatedly, AGM approved the deregistration of three organizations that voluntarily withdrew their membership and these included: Avocats San Frontiers (who are now Strategic Partners under the ADA project); Uganda Youth Development Link and Law and Advocacy for Women in Uganda; re-appointed Osillo & Co. Certified Public Accountants as External Auditors for the last financial year June 2021 to July 2022; membership subscription was increased from UGHS 200,000 to UGHS 300,000 and; amendment of the constitution to include new categories of membership to include special and life membership.

AGM was crowned off with recognition of outstanding members in two categories of participation in LASPNET activities and Utilization of the LASPNET Integrated Information Management System (IIMS).

The organizations recognized were Muslim Centre for Justice and Law (MCJL) was awarded as the most Active member in the utilization of the LASPNET Integrated Information Management System (IIMS) whereas Uganda Christian Lawyers Fraternity was awarded a plaque and certificate of Appreciation for their diligent participation in the LASPNET activities for the period 2020 to 2021. The ceremony was presided over by Hon. Justice Remmy Kasule who applauded the recipients for their unwavering support to the Network.

# 7.4.5. Management of LASPNET meets to develop an institutional Sustainability Plan

LASPNET convened a Board and Management institutional sustainability meeting purposed to reflect and strategize on how to strengthen the sustainability of the Network on the 10th September 2021 at Allure Hotel.

At the meeting, the CEO Dr. Sylvia Namubiru Mukasa extended her appreciation to the Board of Directors and Stanbic Bank team for setting aside time to engage in the meeting and commended Stanbic Bank's selflessness in offering probono services towards the development of the LASPNET Sustainability Plan.

Mr. Arthur Nsereko, Chairperson Board of Directors, re-echoed the CEO in commending Stanbic Bank for supporting LASPNET in the development of its Sustainability Plan.

Mr. Richard Sserumaga, Manager Stanbic Bank, together with his team from Stanbic facilitated the session which led to the development of the LASPNET Sustainability plan (2021/2025) hinged on three critical aspects of Raising, Savings and Investment. This Sustainability Plan was approved by the Board at its sitting 22nd December 2021 making it an operational document institutional. So far among the actions implemented from the Sustainability Plan is the procurement of Land for construction of the Legal Aid House.

## 7.4.6 Membership and stakeholder's Capacity Development Programmes.

LASPNET facilitated 10 Capacity building trainings for its members and stakeholders aimed at strengthening their capacity to deliver standardized legal aid services to their clients. These are highlighted below;

## a) Informal Justice Actors skilled in GBV response and prevention in Mukono; Kayunga and Buikwe districts

LASPNET with support from EU coordinated two capacity building trainings for Informal justice actors to effectively prevent and respond to Gender Based Violence (GBV) within the districts of Mukono, Buikwe and Kayunga from the 16th -19th August 2021 at Colline Hotel Mukono.

The training was facilitated by Hon Justice Eva Luswata, lead facilitator and three gender experts namely; Dr. Consolata Kabonesa from School of gender-Makerere University; Mr. Magoola Henry; and Ms. Asha Mwanga from Islamic Women Initiative for Justice Law and Peace (IWILAP).

Further, the training focused on various topics which include: Unpacking the concept of GBV; legal and institutional framework on GBV prevention; GBV referral pathway as well as the role of informal justice actors in responding to GBV and was attended by 102 participants (50 Male: 52 Female) including CDOs; LCs; Community Paralegals; Youth; PWDs; Women as well as Cultural and Religious leaders.

The two sets of training climaxed with launch of a project entitled "*Empowering* 

the formal and informal justice systems to handle and respond to Gender Based Violence – GBV" and awarding of certificates to participants by Mr. Kiganda Samuel – the District Community Development Officer of Buikwe District. As a result of the training, knowledge and skills of informal justice actors in Buikwe; Kayunga and Mukono on how to respond to GBV was strengthened and skills enhanced.

### b) LASPs trained on Evidence Based Practice for Effective Service Delivery

On the 27th October 2021 at Protea Hotel LASPNET in partnership with HiiL under its project titled **"HiiL Uganda's Innovation Programme."** conducted a capacity building training for Legal Aid Service Providers (LASPs) on how to effectively handle family justice problems through application of evidence-based methods.

The training was attended by 25 participants (14 Male: 11 Female) from LASPs such as MCJL, RLP, UMSC, IWILAP among others.

In his presentation, the Justice Sector Advisor at HiiL, Mr. Tim Verheij appreciated LASPNET for accepting to collaborate with HiiL to implement this project. He called upon member organisations to embrace it by transforming learnt ideas into practicability. He encouraged participants to incorporate more evidence-based practice into their work, in the best way possible by stepping up as role models to inspire peers through talking about values and morals.

Similarly, on 13th December 2021, a virtual follow up training on evidence-based methods for handling and resolving family justice problems was held. The training was facilitated by Mr. Tim Verhiej, Justice Advisor at HiiL and it provided opportunity to LASPs to interact and share experience on how evidence-based to resolution of family problems and was attended by 24 participants (10 Female and 9 Male) including LASPs such as MCJL, AFODE, AAV, UCLF, UMSC, IRCU, FIDA Uganda. As result, the training contributed to the strengthened the participant's knowledge and skills in the evidence-based practices in resolution of family disputes.

Furthermore, the key outcome of the LASPNET/HiiL partnership has been the development of an e-Family Justice platform which is currently being used by LASPs to access information on family justice as well as share success stories arising from family justice cases resolved especially at the community level.

## c) Training of Community and LASP Paralegals on the CSOs enabling environment:

LASPNET in partnership Chapter four, CEPESA and ICNL convened a Paralegal Training on CSO enabling environment from 13th to 15th June 2022 at Esella Country Hotel. The training was attended by 35 (12 Female: 23 Male) participants who comprised of Paralegals from all regions across the country. The training was facilitated by Mr. Peter Magellah (Chapter Four); Mr. Edwin Wanyama (CIPESA); Ms. Sheila Muwanga (FHRI) and Mr. James Nkuubi (Chituo Cha Katiba) who trained on modules such as introduction of human rights; freedom of associate; freedom assembly and freedom of expression and digital security.

The meeting was closed off by the Dr. Sylvia Namubiru Mukasa, CEO, who in her remarks underscored the fact that the shrunk operating environment continues to present CSOs and Paralegals with sustainability challenges in terms of how to thrive as individuals and institution in a very polarized society. As such she implored the paralegals to utilize the knowledge acquired to benefit their communities as well as act as frontline defenders to support the grassroots structures, CBOS in responding to dynamic attacks in the operating environment. The training enhanced the knowledge of Paralegals on human rights as well as navigating the CSO the operating environment.

### d) Mentorship training for Voice Grantees

With support from Oxfam Voice under Linking the and Learning proiect. LASPNET in partnership with Strategic Consultants conducted onsite Link training visits and mentorship visits to equip the influencing grantee staff and rights holders with knowledge and skills in community engagement, social media Advocacy legal aid service delivery and referral mechanism for GBV survivors. the use of the documentation toolkit and Voice Knowledge products among others for efficient and effective Voice grant implementation.

The onsite trainings were facilitated by Project Coordinator L&L and Mr. Vincent

Mutonerwa, the Board member on merit in which six (6) grantees namely the Community Volunteer Initiative for Development (COVOID), Gulu Women Economic Development and Globalization (GWED-G) and Joyi Initiatives Uganda (JOYI) benefited from the training which took place between 10th -14th May, and 20th to 28th June 2022.

The onsite trainings improved the grantees knowledge and understanding in project planning and management, utilization of the Voice digital platforms, strategies of undertaking community engagements among others.

## e) Refresher training for mobile call center Agents

In the reporting period, LASPNET with funding from UNDP convened a refresher training for Mobile Call Agents on 20th May 2022 at the Secretariat. The training aimed at re-introducing the concept of the project activity to the old mobile call agents and to bring the two new mobile agents up to speed with the project activity.

It was attended both physically and virtually by 10 participants (7 males, 4 female) who comprised of 5 call agents and 6 Secretariat staff who included the Director of Programmes, Information Communication and Technology Officer, Monitoring and Evaluation Officer, Project Assistant UNDP, Call Centre Coordinator (Ag), and Project Assistant UNDP. The training equipped the Call Agents with knowledge and skills on usage of handsets; collection of data, reporting; customer care relations i.e. Management and satisfaction as well as the overall concept of the project.

# 7.4.7 The Secretariat Capacity Strengthened to deliver on LASPNET mandate

The Secretariat staff was supported with a total of 2 capacity development opportunities while 6 staff also participated in several different capacity development opportunities. These included:

### i) Personal and Organizational Staff Security Training

On 19th November 2021, staff benefited from a Security training facilitated by Mr. Lubowa Henry, Area Manager Saracen Security Services. It was held in the aftermath of the twin bombings in Kampala at Jubilee Insurance House and Central Police Station on 16th November 2021. The training exposed staff to knowledge and skills on how to use fire extinguishers and detection of bombs.

## ii) Training of Staff on Self-care and mental wellness

LASPNET held its Annual Management, Staff Evaluation and Planning retreat from the 16th to 18th December 2021 at Anderitta Beach Hotel. The retreat was intended to among others take stock of the year's performance including how staff had applied and used the knowledge of the previous capacity development to improve on their performance.

During the retreat staff were also taken through a Well-being Session by Mr. Karis Moses Oteba, the Protection Officer from Defend Defenders. For instance, the facilitator urged staff to remain productive by ensuring that their physical, emotional and spiritual wellbeing is in check. Additionally, he implored the team to prioritise their health first since it is the only thing that can impede them from obtaining their full potential at work.

In the same retreat, the staff undertook institution planning for the year 2022 under the organization's thematic areas of Research and Knowledge; Lobby and Advocacy: Networking, Coordination and Partnership; and the Institutional Strengthening and Capacity Development. The official activities of the retreat were closed off by remarks from Mr. Vincent Mutonerwa, the Board Member on Merit who appreciated the staff for their work and commitment towards the institution and assured them fruitful and eventful year 2022. ## f) LASPs continuously supported use of IIMS

Currently, the IIMS has a total of 32 organizations enrolled although 9 organizations active and using the system. In a bid to improve usability members have been continually trained on its utilization and troubleshooting issues as they arise. Further, a virtual consultative meeting was held on 18th February 2022, where LASPs were encouraged on the benefits of utilizing the IIMS. The meeting recommended several actions which among others include; development of a documentary to popularize the IIMS as well as reaching out to inactive individual members to interest them to use the IIMS. This led to 5 inactive organizations to start using the IIMS which include FIDA Gulu, FAPAD, LDC-Fort portal and FIDA Kabale and HURIFO.



## g) Cases Registered on the IIMS System

Therefore, arising from the continued support to LASPs, and consultative meeting, a total of 10150 cases were entered into the IIMS up from 10114. Out of those entered 6163 were civil cases against criminal which stood at 3987. The gender stood at 3374 for as male cases and 6776 female.

Relatedly, LASPNET with support from IDLO conducted the one regional Integrated Information Management System (IIMS) support visit to LASPs and Paralegals in the Northern Region aimed at assessing the functionality and utilization of the IIMS, as well as introducing the new paralegal referral pathway to LASPs. The visits took place on the 24th and 27th of November, 2021.

## i) Functionalization of the Paralegal Database

In the reporting period, Paralegal database was deployed and installed to additional 4 LASPs such as HURIFO, FAPAD and FIDA during the IDLO IIMS support visits in the Northern Region that were held from 24th to 27th November 2021. The LASPs were also trained on how utilize the system.

Additionally, a consultant was commissioned to upgrade the IIMS with a USSD code to make the paralegal database more accessible and usable.

## 7.4.8 LASPNET Board and Committees

A total of 4 Board Meetings were held in the reporting period to discuss policy and provide oversight functions programmes, activities. finance to monitoring, supervision of recruitment, attending to membership issues as they emerge. In addition, a total of 8 Committee meetings were held including Planning and Programmes Committee; Audit and Finance Committee: Governance and Administration Committee. Advisorv Committee on Governance and Monitoring and Public Interest Litigation Committee to provide oversight.

# 8.0 CHALLENGES, LESSONS LEARNT, RECOMMENDATIONS AND OPPORTUNITIES

## 8.1 Challenges

In the reporting period, several challenges were encountered during implementation which included;

### a) Increased disregard of rule of law

The operating environment continued to be characterized with increased incidents abuse of rule of law and judicial processes by some judicial officials through applying harsh and selective bail terms with the intention of denying various suspects especially in the category of opposition politicians and activists their constitutional right to bail. This doesn't only undermine human rights but also continue to reflect infringements on the judicial independence.

## b) Deteriorating condition of observation and protection of human rights violations

LASPNET has continued to observe a downward trend in respect for human rights and rule of law. Manifestations of such violations include torture which is meted out on dissenting activists notably Kakwenza Rukirabashaijja who was brutally tortured while in Prison before fleeing the country. In addition, the unlawful arrest and detention of human rights activist Norman Tumuhimbise and his crew at Digitalk demonstrate increased suppression of Freedom of Expression in Uganda.

## c) DGF's suspension and exit from Uganda

In relation to the above, due to the suspension of DGF, LASPNET was constrained to effectively respond to the human rights violations following the scale down on operations of Rapid Response Lawyers. Other organizational programming areas were affected by the continued DGF suspension during the reporting period. The affected Programme areas included corruption monitoring, researches, lobby and advocacy initiatives which were all previously funded by DGF. Despite the support received from other donors to meet the DGF gap, it's evident that most of new donors funding mechanisms is short term hence limiting on sustainability.

## d) Persistent delays in remittance of Subscription fees by the members

Payment of subscription is still not being effected in a timely manner by some LASPs, others lack complete commitment to meet membership subscription obligations as at close of the financial year on 30th June 2022, only 20 out of the 53 LASPs had cleared their dues. This is partly attributable to the COVID-19 which left most member organizations crippled and unable to effect payment hence leaving the Network dependent on development partners which is not a sustainable status in the long run.

### e) Emerging economic crisis

Uganda continues to experience an economic meltdown resultina from the global economic crisis. This has subsequently resulted into high cost of living, affected programme implementation in addition to loss of jobs thus contributing to unemployment and poverty which is a huge hindrance for access to justice. This is because 80% of Uganda's population cannot afford services of a private lawyer in a country that still has no state funded legal aid scheme. The looming discussions on oil and its exploration, if not handled transparently would otherwise, turn out to be a double-edged sword for Uganda. Furthermore, there are anticipated injustices likely to arise out of the oil production which include among others displacements without prior compensation of the project affected persons (PAPs) which will require a lot of legal aid services especially for the poor and vulnerable communities.

### (f) Shrinking civic space

During the reporting period, we continued to observe incidents of state overreach on CSOs by various regulatory bodies including NGO Bureau and Financial Intelligence Authority. For instance, a total of 54 NGOs were suspended over allegations of non-compliance. However, on closer observation most of the NGOs suspended are those that critical of government excesses and or operating on issues of governance and accountability such as Chapter Four and CCEDU among others.

## 8.2 LESSONS LEARNT

## a) Intensification of fundraising efforts to identify institutional donors

Following the continued suspension and later exit of DGF from Uganda which was the main institutional donor paying for the majority staff and administration costs of the organization, it has been a lesson to appreciate the importance of developing institutional sustainability plan and to identify more possible partners willing to sustain the organization during such prevailing circumstances as well as coming up with localized ways of resource mobilization.

## b) Adapting community-based programme implementation

This has enabled LASPNET register significant under successes implementation of the EU GBV project in Mukono; Kayunga and Buikwe. Most importantly, it has built citizen agency through community empowerment programmes in form of outreaches to the extent that the district officials and community members greatly feel LASPNET's impact on ground and can also attest to its contribution to the fight against GBV. As a lesson learnt, the Network has now embarked to designing more community-based programmes and the most recent project to adapt such a model is the UNDP Spotlight where Community Legal Aid Mobile Clinics (LAMCs) will be implemented in 8 Spotlight districts of Arua, Terego, Amudat, Kitgum, Kasese, Kampala, Tororo and Kyegegwa.

### c) Collaborations and Partnerships:

The members are willing and able to collectively offer support in various LASPNET engagements whenever

approached and called upon. For instance under advocacy, LASPs such as FIDA Uganda, JCU, LDC-LAC and ULS have demonstrated support towards moving in a harmonized direction in advocating for the enactment of the NLAB into law. Furthermore, LASPs such as IWILAP, AVV, JCU, and JURIA partnering with LASPNET to implement various Programmes such as the EU supported GBV project as well as supporting UNDP supported open days and Mobile Legal Aid

## 7.1 OPPORTUNITIES

a) Increased trust from the public, media and strategic partners: This has enabled LASPNET to remain relevant and a key influence in the area of access to justice; human rights and rule of law.

b) Donor willingness to continue funding governance and accountability work; despite the continued shrinking civic space as well as new donors coming on board to fill up the gap.

c) Organizations' abilities to adapt resilience and survival instincts; to navigate the fragile operating environment through coalitions and cooperation.

## 8.4 RECOMMENDATIONS

In every challenge is a hidden opportunity and or lessons to exploit for better outcome. Therefore, and whereas we cannot stop challenges, the same can be mitigated through undertaking several remedies as discussed below;

a) To address the issue of DGF exit from Uganda, LASPNET and it members recommends the need to undertake robust approaches in fundraising as well as exploring non-conventional funding opportunities such as crowd funding and foundations.

b) There is need for LASPNET and is members to adapt community-based programme models that can accelerate ownership and impact within the broader community. Para legalism and legal volunteers should be strengthened to deliver services in absence of traditional LASPs.

c) To address the challenge of disregard of rule of law, LASPNET and like-minded organizations need to amplify advocacy efforts focusing on constitutional and legal reforms pursued through strategic litigation.

d) The members are encouraged to appreciate that meeting the requirement to pay membership subscription should be a priority rather than a choice if the Network has to implement its sustainability plan.

# 9.0 CONCLUSION

LASPNET intends to pick from lessons learnt and opportunities to galvanize efforts that will ensure effective research and advocacy interventions to fast track the enactment of the National legal aid Law. This will be undertaken in a participatory, coordinated and collaborative manner in a way that builds synergies and cooperation amongst the members and key stakeholders.

In addition, efforts will be undertaken geared towards resource mobilization to address the funding gap left behind by DGF. This will involve identification of other potential institutional donors to support LASPNET and its members.

LASPNET remains grateful to all its Members; Strategic Partners and our Development Partners who have relentlessly supported the operations and growth of the Network.

## Report on the Audit of the Financial Statements

### Opinion

We have audited the Financial statements of Legal Aid Service Providers Network set out on pages 11 to 25 which comprise the statement of comprehensive income, statement of financial position as at 30th June 2022, statement of changes in accumulated fund, statement of cash flows and the notes compromising a summary of significant accounting policies and other explanatory information.
